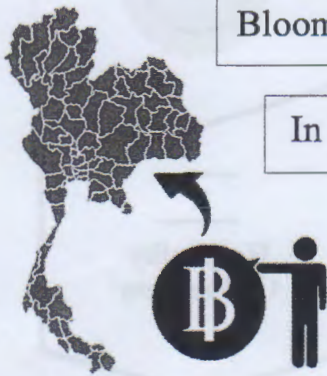
Thai government announced the policy of being an International Medical Hub from 2014 - present

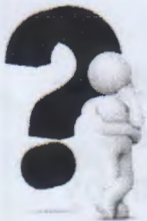
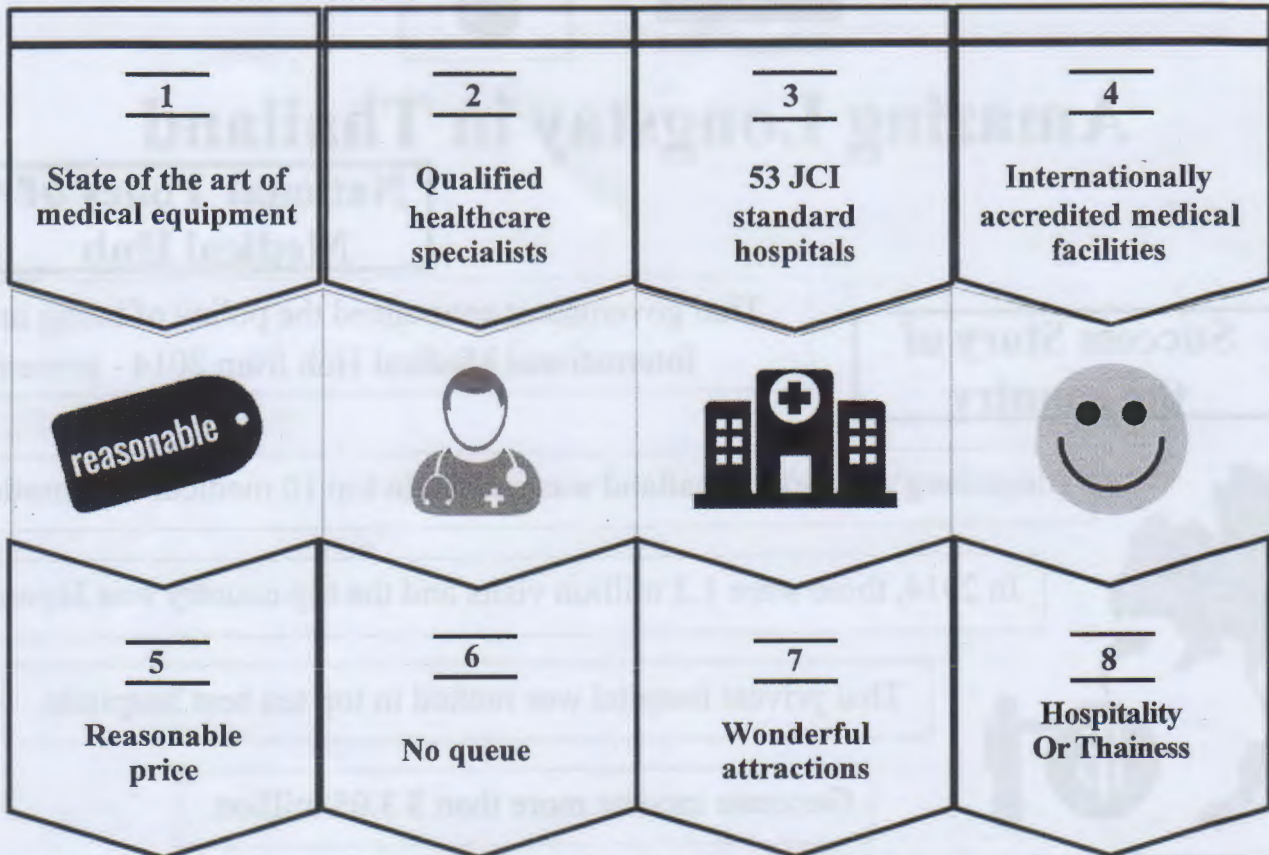

Longstay in Thailand

This type of visa may be issued to applicants aged 50 years and over who wish to stay in Thailand for a period of not exceeding 10 years without the intention of working. It has been approved from the cabinet since November 22, 2016.

Submitting the application for Non-Immigrant Visa "O-A" Long Stay in term of multiple entry at the Royal Thai embassy or Royal Thai Consulate-General in their home/residence country and the person must come to Thailand within 90 days . At arrival, officer at immigration will stamp a visa.

Case I

1st time: will be permitted to stay in Thailand for 5 years from the date of first entry in term of multiple entry. 2nd time: will be permitted to stay in Thailand for 5 years from the date of first entry in term of multiple entry

An applicant who has already lived in Thailand and wishes to apply for long stay visa, must change the visa to Non-Immigrant Visa "O-A" at the Office of the Immigration Bureau in Thailand

1st time: will be permitted to stay in Thailand for 5 years from the date of first entry in term of multiple entry and able to renew. 2nd time: will be permitted to stay in Thailand not more than 5 years from the date of first entry in term of multiple entry and not able to renew

Case II



Differences Between Previous and Current Longstay Visa

Duration of stay: 1 year	Duration of stay: 10 years
Single entry: 3 months Multiple entry: 1 year At the end of the 90-day stay, the foreigner must report to the immigration officer in his or her residence area and report again every 90 days during his or her stay in Thailand	Multiple entry: 5 years (1st) Multiple entry: 5 years (2nd) At the end of the 90-day stay, the foreigner must report to the immigration officer in his or her residence area and report again every 90 days during his or her stay in Thailand
Applicants aged 50 years and over	Applicants aged 50 years and over
Having deposit amount in an account 2,428,658 JPY or income more than 197,328 JPY per month	Having deposit amount in an account 9,107,469 JPY or income more than 303,582 JPY per month
Having medical certificate	Having health insurance documents in duration of 1 year and those documents must be available to declare every year
Must not withdraw the deposit amount for 3 months. Yet, after termination of the period, owner can withdraw in any cases	Must not withdraw the deposit amount for 1 year. Yet, after termination of the period, owner can withdraw not more than 50 percent and must show the evidence of using the money in Thailand only.
Visa fee = 5,768 JPY per person	Visa fee = 30,358 JPY/person (6,072 JPY x 5 years)


